#### Sugar Lake Divers

The Sugar Lake Board would like to thank Steve Klobe and Dan Erdman for the work they do diving on Sugar Lake. We are lucky to have them as a resource. We can all acknowledge their contribution best by being careful if they are on the lake. Please observe the warning flag posted by those diving on the lake. The state flag is red with a white stripe running diagonally from corner to corner and may be displayed from a float or on a boat. A blue and white flag is also authorized under federal rules of the road and is only flown from a boat. The warning flag is used when diving is in progress. No person may operate a watercraft within 150 feet of the red and white flag.



#### Water Quality Improvement

The lab used for the county lake monitoring program we participate in is RMB Environmental Laboratories, Inc. They now offer on-line reporting for their lake monitoring services at www.rmbel.info. Visit the website and take a look at Sugar Lake data.

#### **Lake Vegetation Report**

#### **Automatic Dishwasher Soap Promotion**

In order to promote the use of zero phosphorous automatic dishwasher soap the Sugar Lake Association has purchased 100 packages of Seventh Generation automatic dishwashing products to sell to the membership. A 50 ounce package of powder or liquid is available at an introductory cost of \$4.00. This compares to a cost of \$5.75 for the same product in grocery stores. The small profit made by selling this soap will benefit the lake improvement fund. Using zero phosphorous products benefits the lake. Using zero phosphorus dishwasher soap may also benefit your glassware. Products including phosphorus can etch your glassware giving it a cloudy look that won't clean off. This can happen when used with soft water and relatively clean dishes in the dishwasher. #### Dear Sugar

Dear Sugar, I recently saw a TV news spot on channel 9 about carbon monoxide (CO) poisoning on boats. Should we be concerned about this on Sugar Lake? *Worried waterskier*.

Dear *Worried waterskier*. The short answer is yes, we should be concerned. A little research on the web at sites including the U.S. Coast Guard, the National Institute for Occupational Safety and Health, the Center for Disease Control, and KMSP Channel 9 turned up the following information:

While it has been recognized for a number of years that CO (carbon monoxide) poisoning at the stern of houseboats is a problem it is just within the past two years that it has become evident that CO can be present in deadly concentration behind ski boats, cabin cruisers, even personal watercraft.

CO is a byproduct of internal combustion engines. It is odorless, colorless, and tasteless. When breathed it displaces oxygen in the bloodstream. Symptoms of CO poisoning include rapid onset of headache, fatigue, nausea, dizziness, convulsions, leading to death. Don't confuse CO poisoning with seasickness, intoxication, or heat stress. If someone onboard your boat complains of the symptoms listed above, move that person to fresh air and investigate the cause. Seek medical help unless you are certain it is not CO poisoning.

Ski boats and many boats manufactured in recent years incorporate a swim deck off the boat. Boat occupants often sit on the swim deck while the boat idles or travels at slow speed. The swim deck is directly over the exhaust ports on the boat and the highest concentrations of CO form under and around the swim deck. Some people (no one seen on Sugar Lake) also participate in an activity called "teak surfing" or "dragging" in which they hold on to the swim platform as the boat pulls them, then body surf the boat wake. Boat exhaust is more dangerous than the exhaust from cars. The catalytic converters on cars reduce CO concentrations by more than 90%. Boat engines do not have the same emission controls.

The TV spot on channel 9 detailed tests performed on several boats on Lake Minnetonka. They measured levels of 385 ppm (parts per million) from a small fishing boat motor, 375 ppm at the back of one jet ski, 1000ppm at the back of a 2 cycle jet ski, 400 ppm standing on the swim deck of a larger boat and 1000 ppm at water level on the same boat.

#### **CO Exposure Limits**

35 ppm	Maximum allowed by EPA outside for I hour.
87 ppm	Maximum exposure during a 15 minute interval. World Health Org.
200 ppm	Noticeable symptoms appear
800 ppm	serious symptoms, even death
1200 ppm	Immediately dangerous to life and health
6400 ppm	Death in 10 minutes

Coast guard researchers ran tests 20 feet behind a boat moving at seven miles per hour. Average CO readings reached 135 ppm and peaked at over 400 ppm.

#### In summary:

- Don't allow any activity around the stern of your idling or slow moving boat.
- Tube or ski more that 20 feet behing the boat.
- Educate your passengers on the dangers of CO.
- Maintain your boat exhaust system.
- Don't confuse CO poisoning with seasickness, intoxication, or heat stress.

#### **First Flush Fundamentals**

The biggest problem with rain run-off is what happens to the first quarter or half inch of rain the falls after a dry spell of days or weeks or months.

The <u>First</u> rain after a dry period can carry the most contaminates. The first heavy rain will <u>Flush</u> any available debris into the lake. The debris can include grass clippings, lawn fertilizers and chemicals, dust and dirt from walks and patios, and road debris from parking areas including road chemicals, heavy metals from exhaust, and rubber particles. The <u>Fundamentals</u> of what we can do include:

- We can divert water to a holding pond, a rain garden, or a longer route to the lake.
- Install or retain an ice ridge that creates a natural dam at the shoreline to prevent water from running directly into the lake.
- Slow down the water flow so it can't carry as much debris by making grading changes or planting buffer strips.
- Make provisions to absorb the retained water with holding ponds, interrupter trenches, or rain gardens.
