Water Quality Improvement

Another missed opportunity in the Sugar Lake watershed:

Once again a project was undertaken in our watershed without adequate forethought and preparation, and our environment has paid the price.

The project in mind was the creation of a deeper ditch along the road to direct water to a culvert that takes it to the lake. What happened in this case, is that the county allowed the property owner to start the project too late in the fall so that there was not enough time to re-vegetate the excavated soil. Due to this fact, there was considerable erosion of topsoil deposited into the lake in the fall, and again in the spring. Recently, after discussion with the county again, the property owner re-graded the ditch for a second time. Once more he attempted to reestablish the soil without the use of any "Rolled Erosion Control Products," on the bottom of the ditch. Instead the contractor was allowed to simply install two bands of silt fence across the channel. With the first heavy rain the system failed and considerable silt was deposited into the lake yet again.

As stated in the Field Manual on Sediment and Erosion Control Best Management Practices for contractors and inspectors, "Vegetation provides the best method for reducing erosion in drainage channels ... establishing vegetation in bare-ground drainage channels is difficult when flows occur. The use of RECPS (Rolled Erosion Control Products) might alleviate this problem." (pg. 109)

This manual, as well as others, tells us exactly how to do this, but we do not require the landowner or the contractor to follow these guidelines, and therefore, they don't. This project has been the subject of conversation for many decades, so it is not something new, nor a spur of the moment decision. It does, however, point out the fact that we have lots of work to do in educating residents on the importance of "Best Management Practices" when it relates to earthwork near our lakes and rivers. When are we going to start taking care of our environment by at least telling people how to do it right?

As development continues in Wright County problems like this will continue unless we start to do something now. Let's start to find ways for all of us to do our projects without having to jeopardize our water quality. Any time we remove vegetation around the lake we need to have a plan for protecting the soil until new vegetation is established. NO project is too small for this kind of planning.

<u>Diane's Lights Night</u>

Although Diane's Lights Night signals the end of summer, it also hails in one of the most beautiful nights of the year on Sugar Lake. In this second in a series of articles, we will be giving you ideas on how to make this night even more spectacular.

In the last article, It was mentioned how difficult it can be to keep your luminaries going if it is raining or the wind is blowing. Although white bags make the best looking luminaries, an alternative in bad weather might be white or semi-clear plastic milk jugs. You can use either the half-gallon or gallon size. Simply cut off the top, remove the labels with mineral spirits, put sand in the bottom to stabilize them, and insert a tea light candle. The jugs can be saved, so you can make a more impressive display next year, and the tea lights are very inexpensive to purchase. Another thought is to mix the bags and jugs to enhance your design. Remember, only light originating from a flame qualifies you for the best individual display prize.



Next month, we will let you know what the prize will be for having the best display, but remember, everyone who participates is a winner through their contribution to the night and their community spirit. Lets make this year's Diane's Lights Night the best ever.



Floating docks

A fun way to enjoy the lake, as well as entertaining our housequests, is to take a boat or pontoon ride around its shores. Every spring I look forward to that first ride and see what's changed. If you have ever done this at night, it gives you an entirely different perspective of the lake and is every bit as enjoyable. There are some hazards to a night ride, however, and one of them is the floating docks. The law requires each dock to have reflectors on all sides. Unfortunately, they only work if light is first shone on them. It would be terrible if an accident occurred. Not only would there be property damage, but personal injury or even death may occur. As a floating dock owner, you might consider purchasing a solar light. Once installed on your dock, they are virtually maintenance free and the prices start at under \$20.00. The light will make your floating dock more visible at night. If stored correctly over the winter, they will last many boating seasons. Lets make this a safe boating season.
