Please see the below summary of aquatic invasive species inspection activities on Sugar Lake. Note that while both North and South access data are reported funds from Sugar Lake Association only funded hours on the South Access.

Figure 1. Inspections by date at Sugar Lake Accesses





Based on entering inspections boater came from 261 different waterbodies, 34% of boater were returning to Sugar Lake. Boaters will go to 139 different waterbodies and 43% will visit Sugar Lake again on their next trip.
